



DRAFT BY-LAW RESPECTING THE REMUNERATION OF ELECTED MUNICIPAL OFFICIALS

PUBLIC NOTICE is given according to section 9 of the *Act respecting the remuneration of elected municipal officers* (CQLR, c. T-11.001) that notice of motion was given and that a draft by-law entitled "**BY-LAW 1531 RESPECTING THE REMUNERATION OF ELECTED MUNICIPAL OFFICIALS**" was tabled by Councillor Jeff J. Shamie at the regular sitting of the Municipal Council of the City of Westmount held on December 3, 2018.

None		<p>A refund may be granted to a member of Council who must use his motor vehicle in order to carry out a trip on behalf of the City, as follows:</p> <ul style="list-style-type: none"> • \$0.55 for each kilometer travelled up to a maximum of 350 kilometers in a month; • \$0.49 for each kilometer over 350 kilometers during the same month. <p>The rate mentioned above will be adjusted annually, based on the automobile allowance rates published by the Government of Canada in September of the previous year.</p>	

The draft by-law provides that the above-mentioned remunerations will be indexed annually, as of January 1st, according to the consumer price index. The applicable minimum is 1% and the maximum is 2.75%.



The draft by-law provides that the Acting Mayor will receive an additional remuneration to that paid to her or him as a member of Council, in order that the total remuneration payable during the replacement be equal to that of the Mayor, on a prorated basis

This by-law, if adopted, will come into force as of January 1st, 2019, retroactively.

This draft by-law will be submitted for adoption at the regular sitting of Council which will be held in the Council Chamber at City Hall on **Monday, January 14, 2019 at 7:30 p.m.**
