6.2. MINUTES OF THE GENERAL COMMITTEE OF COUNCIL

The minutes of the General Committee meeting of Council held on August 3, 2020 are tabled and are available on the City's website.

7. EXTENSION OF A CONTRACT - SUPERINTENDENT - ROADS - PUBLIC WORKS

WHEREAS according to section 71 of the *Cities and Towns Act* (CQLR, c. C-19), the Council shall appoint by resolution such officers and employees as it deems necessary for the administration of the city, and shall fix their salaries;

WHEREAS on April 1, 2019, the Municipal Council adopted the *Working Conditions and Remuneration of Management Personnel*;

WHEREAS at its sitting held on October 23, 2019, the Municipal Council appointed Mr. Denis René to the position of Superintendent – Roads of the Public Works Department for a period of 22 weeks, from November 4, 2019 to April 4, 2020 (Resolution No. 2019-10-223);

WHEREAS at its sitting held on March 2, 2020, the Municipal Council extended the contract of Mr. René for a maximum period of four (4) weeks, from April 5, 2020 to May 2, 2020 (Resolution No. 2020-03-41);

WHEREAS at its sitting held on May 4, 2020, the Municipal Council extended the contract of Mr. René for a maximum period of eight (8) weeks, from May 3, 2020 to June 27, 2020 (Resolution No. 2020-05-85);

WHEREAS the Director of Public Works recommends the extension of Mr. René's contract to the position of Superintendent - Roads of the Public Works Department.

MOVER Councillor Shamie SECONDER

THAT the contract of Mr. Denis René for the position of Superintendent - Roads, grade 8, in the Public Works Department, be extended for a maximum period of 31 weeks, from September 28, 2020 to April 30, 2021, according to the needs of the Department, the whole in accordance with the recommendation of the Director of Public Works and the terms provided for in the *Working Conditions and Remuneration of Management Personnel*.

8. GROUP PURCHASE WITH THE CITY OF MONTREAL - ROAD SALT FOR THE WINTER SEASON OF 2020-2021

WHEREAS according to Section 572.1, paragraph 2 of the *Cities and Towns Act* (CQLR c. C-19), a municipality may enter into an agreement with another municipality in order to call for tenders for the purpose of awarding contracts;

WHEREAS the City of Montreal published a call for tenders on May 20, 2019 for the supply of road salt for the 2020-2021 winter season for the nineteen (19) boroughs, fifteen (15) demerged cities of the Montreal Agglomeration and the *Société de transport de Montréal* (Tender No. 20-18120);

WHEREAS tenders were publicly opened at Montreal City Hall on June 25, 2020;

WHEREAS at its regular Council sitting held on May 19, 2020, the municipal Council mandated the Purchasing Manager to act as a representative of the City for this call for tenders (Resolution No. 2020-05-92).

To authorize an expenditure in the amount of \$233,263.33, including tax credits, for the 2020 fiscal year, for the supply of approximately 10,000 metric tons of regular road salt and approximately 250 metric tons of processed salt for the winter season of 2020-2021;

THAT, as part of the City of Montreal group purchase contract, the tender of *Cargill Limitée* be accepted for a total amount of \$766,360.11, all applicable taxes included;

To allocate this expenditure in accordance with the financial information included in the decision-making file No. 2020-1053.

9. GROUP PURCHASE WITH THE CITY OF MONTREAL - PURCHASE OF FUELS

WHEREAS according to Section 572.1, paragraph 2 of the *Cities and Towns Act* (CQLR c. C-19), a municipality may enter into an agreement with another municipality in order to call for tenders for the purpose of awarding contracts;

WHEREAS the City of Montreal published a call for tenders on August 12, 2020 for the supply of various bulk fuels for the City of Montreal grouping (Tender No. 20-18226);

WHEREAS tenders will be publicly opened at Montreal City Hall on September 22, 2020;

WHEREAS the City of Westmount wishes to participate in this group purchase with the City of Montreal.

MOVER Councillor Cutler SECONDER

THAT Council authorize the City of Westmount to participate in the group purchase with the City of Montreal for the supply of various bulk fuels for the City of Montreal grouping (Tender No. 20-18226);

THAT the Purchasing Manager be mandated to act as a representative of the City for this call for tenders and be authorized to sign any and all documents required to give effect to the present resolution.

10. AGREEMENT FOR THE RENTAL OF TRUCKS FOR SNOW REMOVAL OPERATIONS - WINTER 2020-2021

WHEREAS in accordance with paragraph (3) of section 573.3 of the *Cities and Towns Act* (CQLR, chapter C-19), the City may enter into a contract whose object is the supply of bulk trucking services if it is entered into with the holder of a brokerage permit issued under the *Transport Act* (CQLR, chapter T-12);

WHEREAS *Transvrac Montréal-Laval inc.* is the holder of a Transport Brokerage Permit - Bulk Trucking in accordance with the City's specifications for the supply of trucks.

SECONDER

THAT an agreement be entered into with *Transvrac Montréal-Laval inc.* for the supply of forty (40) trucks for snow removal operations during the 2020-2021 winter season, for a minimum guarantee of \$9,500.00 (before taxes) per truck, based on the hourly rates fixed by the *Ministère des Transports du Québec*;

To authorize an expenditure in an amount of \$307,482.14, including tax credits, for the 2020 fiscal year, for the supply of forty (40) trucks for snow removal operations during the 2020-2021 winter season;

To award to *Transvrac Montréal-Laval inc.* the contract for the supply of forty (40) trucks for snow removal operations during the 2020-2021 winter season for a minimum amount of \$380,000.00 plus taxes and a maximum amount of \$1,171,500.00 plus taxes;

To allocate this expenditure in accordance with the financial information included in the decision-making file No. 2020-1073;

THAT the Director General be authorized to sign the agreement and any other document required to give full effect to this resolution.

11. NOTICE OF MOTION - BY-LAW 1563 TO FURTHER AMEND BY-LAW 1544 TO ESTABLISH TARIFFS FOR THE 2020 FISCAL YEAR - PLAYING FIELDS
